Terms and Conditions

1. General issues/ clarifications:

- 1.1. In the event of both caesarean surgery and child birth claims are submitted, **<u>both claims</u>** could be honored.
- 1.2. In the event customer maintains <u>several accounts</u>, the aggregate balance of all accounts to be considered.
- 1.3. In the event of both parents being account holders, <u>only one claim</u> will be entertained.
- 1.4. Necessary documentation should be submitted in order to receive grants and must be submitted **within 3 months** from the event.
- 1.5. Customers who have obtained credit facilities against their LKR savings and current accounts balances (full/partial) are **not eligible** to receive rewards under Seylan rewards scheme (Staff should clearly explain to customers).
- 1.6. Customers, who have obtained credit facilities in foreign currency (Foreign Currency Loans) against their <u>FCY deposit balances</u>, are eligible to receive rewards based on the <u>leeway in balance</u> maintained with the bank for the stipulated period.
